



### Trailer Rental Agreement

Both parties agree to the terms and conditions regarding the rental of K C Marine Services, Inc. (hereafter referred to as KCM). The renter agrees to pay for all damages to the trailer incurred during the rental period. The renter will be held liable for damages to other property caused by the trailer during the time of rental. The renter understands that the Red Carpet Boat Trailer Rentals will not be held liable for any mechanical trailer malfunctions including brakes and light malfunctions, etc., which may cause property and/or personal damage or injury.

Pick-up and drop off times are normal business hours, 9 am and 5 pm, unless other arrangements have been made. The renter agrees to pay \$15.00 PER hour late fee during normal business hours. This \$15.00 late fee is charged per hour after a one hour grace period. Unless arrangements are made trailer cannot be returned after hours. After six hours past the expected drop off time, or after close of business day, trailer renter will be charged an additional day. The renter agrees to pay all late fees and damage charges or repairs in cash or by the credit card listed as a security deposit. Pick-up or delivery of the trailer, within 20 miles (each way) of KCM offices, can be arranged at a cost of \$50.00.

Trailer renter agrees to keep a valid credit card on file with KCM, to be used solely for the trailer rental fees and/or damages. Trailer renter agrees to pay for any damages upon returning the trailer.

The trailer is intended for boat or personal watercraft hauling only. It is understood that no other cargo will be hauled.

KCM will not haul, launch, transport or pick-up boats.

I fully understand that there are certain risks and dangers associated with renting equipment that cannot be eliminated regardless of the care taken to avoid such risks. I fully assume the risks involved as acceptable to me, and I agree to follow all safety instructions. I am fully aware of the capacity of the trailers and the weight of my boat. I will not tow any vessel with a weight capacity over the above limits. I assume responsibility for all property damages incurred during the rental period in related or caused by the rented trailer. State law requires that all towed boats must be strapped in two places from the trailer to the stern of the boat. I agree to keep boat strapped while moving with the supplied straps.

Renter understands and agrees that the trailer will not be towed outside the State of Florida. During any rental period going beyond 1 week (7 days) KCM is authorized to collect the accrued funds up to that time period and every 7 days or 1 week period thereafter by collecting the funds from the credit cards on file.

Normal adjustments made to bunks or rollers by the renter to accommodate his/her vessel will be allowed, however, the trailer must be returned in its original condition.

I, release, indemnify, waive, covenant not to sue and hold harmless KCM along with any of its employees and affiliated contractors from any suits, cost and expenses for damages including attorney fees for personal injury, property damage, accidents or any incidental damages that may arise from the use of the rental trailer.
